The following is a brief description of the duties of each office per our bylaws:
(paraphrased)

PRESIDENT: The President shall in general supervise and control all of the business and affairs of the Corporation & when present, preside at all meetings.

PRESIDENT ELECT: The President Elect shall, in the absence of the President, perform the duties of the President.

VICE PRESIDENT: The Vice President shall, in the absence of the President Elect & President, perform the duties of each. The Vice President will also chair a committee that plans, manages and implements the annual banquet. SECRETARY/TREASURER: The Secretary/Treasurer shall attend general membership & board meetings and shall prepare & maintain proper minutes. The Secretary shall have custody of & protect all records. The Secretary will chair a committee that plans, manages, and implements the Nominating Committee. The Secretary shall be the principal financial officer of the Corporation & shall have custody of & be responsible for all funds of the Corporation. He/she shall sign checks and shall receive & give receipts for moneys due and payable and make deposits. The Secretary shall keep adequate & correct accounts and shall submit to the Board & the President statements of the financial affairs.

DIRECTORS: The business and affairs of the Corporation shall be managed under the direction of the Board of Directors which consists of five (5) officers and six (6) Directors. A Director shall perform all duties in good faith, in such a manner the Director reasonably believes to be in the best interests of the Corporation. Board meetings are held quarterly & generally the 1st Monday of the 1st month of each quarter. Directors serve for a term of two (2) years.



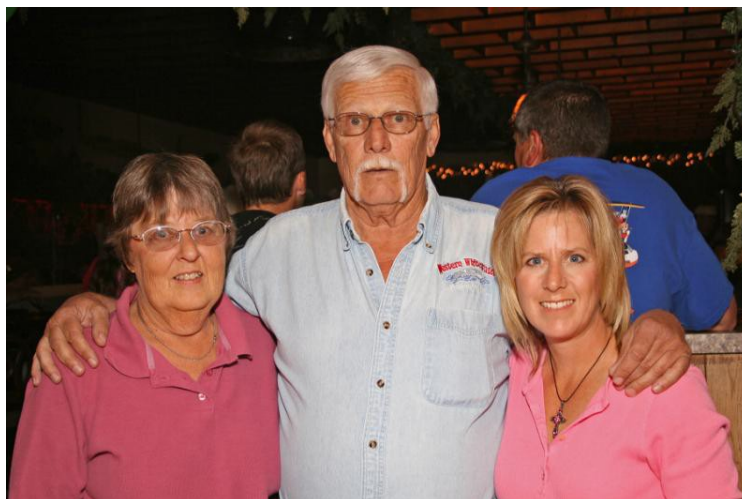

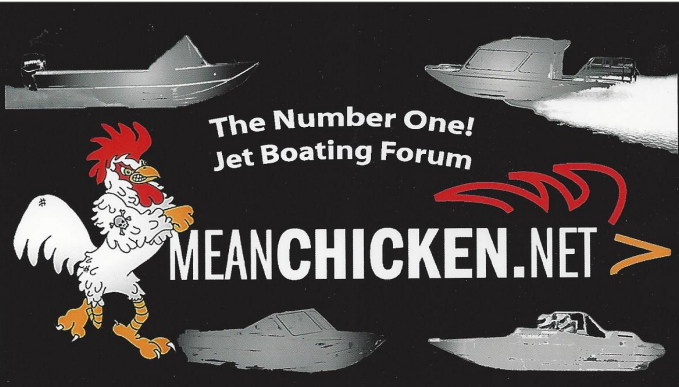
